6. The Competent authority reserves the right to postpone/cancel the recruitment process at any stage. The Selection Committee has the right to select or reject the application of any candidate.
7. The number of vacancies for all the above posts is liable to vary. This is subject to change without any notice
8. **No TA/DA will be admissible for attending the Interview.**
9. The candidates should report for Interview at the stipulated date/time. Verification of documents will be done before the interview. **No candidate will be allowed after 10:00 AM in respect of SRF (Siddha) and 03:30 PM in respect of Therapist.**
10. Interested candidates may, in their own interest, ensure that they fulfill the eligibility conditions. Ineligible candidates will not be allowed to appear for the interview.

(only if age relaxation is claimed)
- 5) **Experience certificate:** Certificate indicating clearly the name of the Organization, duration of employment (date, month & year), nature of duties, pay drawn, etc.
