

**WALK-IN- INTERVIEW**

The Central Council for Research in Siddha (CCRS), Chennai, an Autonomous Body under the Ministry of AYUSH, Government of India proposes to engage the services of two Siddha Pharmacists in SRRI, Puducherry. The engagement will be purely on contract basis, initially for a period of six months. The selection will be made on the basis of Walk-in-Interview to be held on Thursday, the **30<sup>th</sup> July, 2015 at 10:00 AM in the Central Council for Research in Siddha, SCRI Building, Anna Government Hospital Campus, Arumbakkam, Chennai 600 106.**

**General Conditions**

1. Age and experience of the candidates will be determined as on 1<sup>st</sup> July, 2015. Age relaxable in the case of SC/ST/OBC/PH candidates as per Government Rules
2. The appointment will be initially for a period of six months or till such time the regular incumbent joins, whichever is earlier.
3. The period of engagement of Siddha Pharmacists may be curtailed or extended at any time at the discretion of the competent authority.
4. The engagement of above posts will be purely on contractual basis and **it confers NO right to claim for continuation or regularization of appointment**
5. The candidates who fulfill the requirements may attend the walk-in-Interview along with an application in the prescribed format (Annexure I).
6. The candidates should bring with them the originals of all the documents/certificates etc. for verification.
7. The Competent authority reserves the right to postpone/cancel the recruitment process at any stage. The Selection Committee has the right to select or reject the application of any candidate.
8. The number of posts may vary depending on the Council's requirements.
9. **No TA/DA will be admissible for attending the Interview.**
10. The candidates should report for Interview **at 09.30 AM on 30.07.2015**

11. Interested candidates may, in their own interest, ensure that they fulfill the eligibility conditions. Ineligible candidates will not be allowed to appear for the interview. Verification of documents will be done before the interview.

**List of ORIGINAL DOCUMENTS to be brought on the day of interview**

- (i) Matriculation/10<sup>th</sup> Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10<sup>th</sup> Standard or equivalent issued by the Central/State Board indicating Date of Birth in support of their claim of age. Where date of birth is not available in certificate/mark sheets, issued by concerned Educational Boards, School leaving certificate indicating Date of Birth will be considered (like in case of Tamil Nadu & Kerala).
- (ii) 12<sup>th</sup> or equivalent certificate with science subject, as proof educational qualification claimed
- (iii) Diploma certificate along with mark sheets pertaining to all the academic years as proof of educational qualification claimed. In the absence of Diploma certificate, provisional certificate along with mark sheets pertaining to all the academic years will be accepted.
- (iv) Certificate from the Organisation/Department for the entire experience claimed, clearly mentioning the duration of employment (date, month & year) indicating the basic pay and consolidated pay, nature of duties performed/experience obtained in the post(s). Only the experience in the field relevant to the post would be considered.
- (v) Community certificate in case of candidates belonging to SC/ST/OBC from the Competent Authority. The candidates claiming OBC status may note that certificate of creamy layer status should have been obtained within three years before 01.07.2015.
