The Indian and Chinese armies have six hotlines — two each in eastern Ladakh, Arunachal Pradesh and Sikkim — between their ground commanders. The sixth one was set up between Kongra La in north Sikkim and Khamba Dong in the Tibetan Autonomous Region in August last year. China, however, has been dragging its feet over establishing a top-level hotline like the DGMO one between India and Pakistan.

The hotline between the two Army headquarters was first proposed in the bilateral Border Defence Cooperation Agreement (BDCA) signed in 2013 and then agreed to during PM Narendra Modi's visit to China in 2015.

CAG: 2lk trusts not registered for exemption got tax breaks

New Delhi: A comprehensive audit report of the income tax department has revealed that more than 2,000 charitable trusts which had not been registered for exemption were granted tax exemptions to the tune of Rs 18,800 crore between 2015 to 2019.

The highest exemptions of Rs 4,245 crore were availed by 1,345 such trusts based in Delhi, followed by Maharashtra where 3,745 trusts were allowed exemption of Rs 2,500 crore, over 2,300 trusts in UP availed Rs 1,800 crore tax free income while 199 trusts in Chandigarh for Rs 1,600 crore.

Madhya Pradesh also came third with such trusts availing exemption of over Rs 1,500 crore and over Rs 1,000 crore exemptions each claimed by trusts under similar conditions in Gujarat, Andhra and Karnataka.

Interestingly, the auditor in its report tabled in Parliament on Monday, found at least 347 trusts received foreign contributions despite not even having foreign contribution regulation act (FCRA) registration.

Charitable trusts are required to obtain registration under Section 12AA of the I-T Act for claiming exemptions on their income under Section 11 of the act. "From the data provided by the principal

audit officer general of IT systems, pertaining to IT returns for assessment year 2016-17 to 2019-20, auditor found that in 2,385 cases exemption were claimed under Section 11 however registration under Section 12AA was not available," the report said.

These trusts are required to obtain registration under FCRA for receiving foreign contributions. In 347 cases, the CAG said, foreign contributions were received though registration under FCRA was not available. The audit found that Karnataka had the highest receipt of foreign contribution without registration under FCRA Act, followed by Andhra Pradesh and Telangana.

Man with ISIS links held for planning bomb blast on I-Day

Lucknow: The Uttar Pradesh Anti-Terrorist Squad (UPATS) on Tuesday arrested one Sabauddin Azmi (24) from Mubarakpur in Azamgarh district of UP for planning an IED blast on Independence Day. Additional director general of police (law and order) Prashant Kumar said Azmi, who is a member of AIMIM, was in touch with a listed ISIS recruiter and had subscribed to the

banned terror organisation's official Telegram channel.

"We received information about Azmi from our partner agencies that a person in Mubarakpur, who is influenced by the ISIS ideology through his associates, is spreading jihadi ideology through WhatsApp and various social media applications. He is also encouraging others to join ISIS," said Kumar. The
