General Conditions

1. **A written test will be held, if need be**, depending on the number of candidates, followed by interview on the same day, of those candidates, who qualify in the written test.
2. Age of the candidates will be determined as on the date of interview. Age relaxable in the case of SC/ST/OBC/PH candidates as per Government Rules, in the case of Consultant (Siddha)/Research Associate (Siddha).
3. The term of engagement for the positions of Consultant (Admin) and Domain Expert (Siddha) shall ordinarily be for an initial period not exceeding one year, which is curtailed in the midway or extended at any time at the discretion of the competent authority by another one year. Beyond two years after the age of superannuation, where adequate justification exists, the term may be extended based on a review of the task and the performance of the contract appointee, provided it shall not be extended beyond five years after superannuation.
4. The appointment will be initially for a period up to **31.03.2024** for the above said positions, which may be extended further for a period of one year.
5. The engagement of above posts will be purely on contractual basis and **it confers NO right to claim for continuation or regularization of appointment.**
