The Central Council for Research in Siddha (CCRS), Chennai, an Autonomous Body under the Ministry of Ayush, Government of India proposes to engage the services of personnel on contract basis, as per the details given below. The selection will be made based on the personal interview and the date of Interview will be intimated later through e-mail to eligible candidates and through the Council website. If considered necessary, written test will be held on the same day, to shortlist the candidates. The decision of the Competent Authority will be final in the selection process. The number of posts may vary according to need and place of posting.

- 2. Incomplete application, application not submitted in prescribed format and application without supporting documents asked for, shall be summarily rejected.
- 3. Applications are called for various Projects under Intra Mural Research & Siddha Pharmacoepia works. Hence, the candidates <u>need not</u> submit separate application for each project. However, invariably they are required to comply the column @ Sl. No.12 of application format (Annexure I).
- 4. The Name of position is required to be superscribed on the envelope containing the application.
- 5. Age and experience of the candidates will be determined as on the closing date of receipt of Application. Age relaxable in the case of SC/ST/OBC/PwD candidates as per Government Rules issued from time to time.
- 6. The appointment will be initially for a period of one year with subsequent extension based on the performance maximum up to 2 / 3 years or Co-terminus basis. The tenure may be curtailed or extended as may require at the discretion of the Competent Authority.
- 7. The engagement of above posts will be purely on contractual basis and it confers No right to claim for continuation or regularization of appointment.
- 8. The position of SRF/ JRF/ RA-1 is in no way linked to the registration for Ph.D. This is absolutely for IMR projects of CCRS.

- 10. If considered necessary, written test will be held on the same day, to shortlist the candidates.
